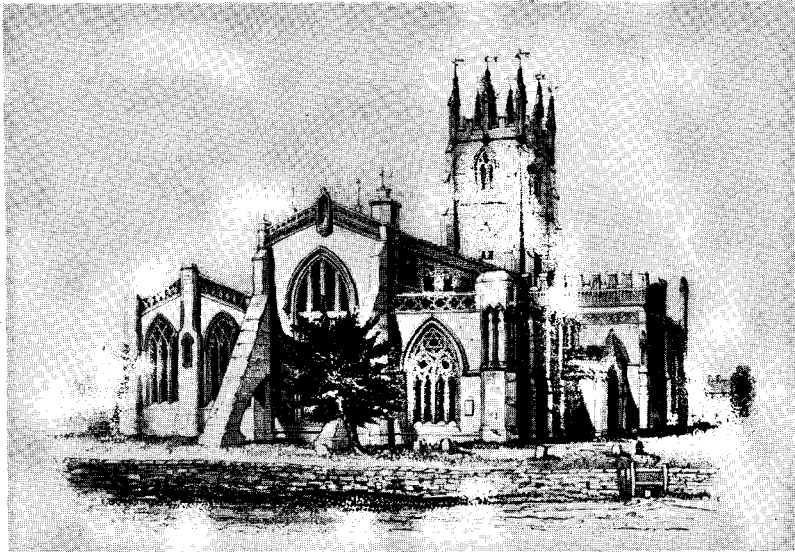

SECOND ANNUAL REPORT
1959

The Committee has pleasure in submitting its second Report and Statement of Accounts for the year 1959.

Membership: Numbers have risen steadily from 121 to 145 (including 23 Life Members and 5 Corporate Members,) despite the loss of 16 previous members.

At a General Meeting on 19th September the rules concerning membership were changed, so that classes and subscription rates are now

- (a) Full or Records, and Corporate - 25/-; (b) Ordinary 10/-;
(c) Junior 5/-.

At the same meeting it was agreed that a Records Section be started, in 1960, the publications of which would be received by Records and Corporate members.

Accounts: The general Revenue Account shows the subscription income just keeping pace with expenses. As the largest item, for printing, includes both the cost of the 1958 Annual Report (£13) and the first two numbers of "Cake & Cockhorse", this is not unsatisfactory. The increase in income that should result from the higher subscription rates in force for 1960 should comfortably cover the regular expense of the magazine, especially as this now incorporates the Annual Report and list of members.

It is particularly pleasing to be able to report that the loan of £40 outstanding has, in the year under review, been paid in full. This means that all future proceeds from sales of "Old Banbury", of which ample stocks remain, can be devoted to subsidising the records publications. A useful profit was made on the Christmas and postcard of the Cross.

Lectures and Visits: Four general meetings (including the A.G.M.) have been held, when the following Lectures were given:-

- January "Eminent Banburians" - Dr. E.R.C. Brinkworth
March "Deserted Medieval Villages" - J.G. Hurst
September "Worthies of Banburyshire" - Dr. E.R.C. Brinkworth

November "Scientific Techniques in Archaeology"
- Dr. M.J. Aitken.

There were also excursions in the summer to Edgehill, when Miss M.R. Toynbee spoke on the battle, and to Rousham House. Mr. Bromley conducted an archaeological tour of nearby Northamptonshire, preceded by a talk on the subject. To all our speakers, who have given their services for nothing, we are most indebted.

Archaeology: Work was concentrated on the site of the Castle, where two deep trenches were dug well into the mound. The most spectacular finds were the partial skeletons of two soldiers probably killed in the Civil War. A detailed interim report has already appeared. Our thanks should be recorded to the energetic group, most of whom were still at school, who did so much manual labour; and also to the Borough Council for permission to excavate on their land, and offer of municipal labour.

A close watch is being kept on the threat to a number of local sites of importance within the area proposed for iron-stone mining.

Magazine: In September the first issue of our magazine "Coke & Cockhorse" was published. This records the Society's proceedings and also contains articles, letters and queries. It is sent free to all members, and four issues a year are planned.

Publications: Also in the autumn was the Society's long-heralded first records publication finally published - the "Index to Wills Proved in the Peculiar Court of Banbury", edited by J.S.W. Gibson. This was published jointly with the Oxfordshire Record Society and printed by Henry Stone & Son (Printers) Ltd., without whose very substantial assistance its production could not have been contemplated. Price to members, 12/6d, non-members, 21/-.

The next records publication will be the first volume of the Banbury parish register, 1558-1653, and will be the first to be issued by the Records Section in return for 1960 Records subscriptions of 25/- (20/- to Life Members).

The Christmas Card was taken from the 1860 view of the Cross, and proved very popular.

Record Copying: For a large part of the year work was continued on Banbury Parish register, though this was brought to a halt in the autumn by Mrs. Fillmore's departure to St. Albans, and Mrs. Pain's illness. The second volume, to 1723, has been completed, and of the third marriages have been copied to 1754 and burials to 1740. Mrs. J.C.B. Coffin has copied the available registers of Warkworth and Marston St. Lawrence, from 1813 to 1840 - the earlier registers are unfortunately largely destroyed. Mr. Gibson and Miss A. Lillie have copied the registers of Swalcliffe (1558-1840) and Shutford (1698-1840), and Mr. Gibson has also copied most of the 19th century alphabetical transcript of the register of the Society of Friends Banbury Monthly Meeting. A copy of part of Radway register has been lent by Miss C.H. Mackay.

L E C T U R E

FIRE FIGHTING FROM A VAUXHALL

For many years the Banbury Fire Brigade used a second-hand Vauxhall car as their tender, because the Council wouldn't buy a proper one. Even this they had had to buy themselves, though the Council thought it advisable to pay the insurance! This was one of the many incidents related by Mr. F.H. Anker to the Banbury Historical Society on the evening of Tuesday, 26th January, at their meeting in the Town Hall. He was speaking on "The History of the Banbury Fire Brigade", and it proved a fascinating example of how local history comes right up to date. After outlining the history of fire-fighting in this country and elsewhere, Mr. Anker described how our own brigade, like most, had grown up from a volunteer force formed in the 19th century; though there had been fire-engines of a sort stationed in Banbury, Neithrop and at Lampitt's foundry since the early 18th century, and many villages had

them also. Insurance Companies have traditionally supported fire brigades, but gradually the Borough Council became more involved in it, and finally took over complete financial responsibility.

This was by no means originally the case, and Mr. Anker read out items of the cost of a big fire in 1859, when 400 men were involved at 2/- a head, not to mention the cost of refreshment, particularly liquid!

More recently (though before 1914) he quoted as a typical example a fire at Evenley Hall. Here the brigade was summoned by telegram, and it was over two hours before they were even able to start by horse-drawn transport to the fire. A further two days were to elapse before they returned!

Numerous questions showed what great interest Mr. Anker had aroused, especially in his many exhibits. These included helmets fire marks and plates, models of pumps and pictures. Amongst several books was a 17th century Dutch one, with most graphic engravings of the earliest fire appliances. In the absence of Dr. C.F.C. Beeson the Chair was taken by Mr. J.H. Fearon, and the vote of thanks was proposed by Mr. G.J.S. Ellacott.

The threat of iron-stone mining in the beautiful country around Bloxham, Adderbury, and further south, has again been raised. The despoiled countryside around Wroxton is answer to any but the most utilitarian of arguments about the success of reclamation, and it is plain that north Oxfordshire will be ruined for our lifetime if the mining and steel companies have their way. We are sure that all our members deplore this eventuality, if on grounds of amenity alone. We hope however to add our voice to the opponents of the scheme effectively on the grounds of the threatened destruction of several important archaeological sites.

THE WARWICKSHIRE HEARTH TAX RETURN FOR 1663.

The following lists are of householders who were liable to pay the Hearth Tax in 1663, and also of those not liable, usually paupers. They form a valuable indication of the state and size of village populations. The Return for 1665 for Oxfordshire was printed in Vol. 21 of the Oxon. Record Society. Recently the Returns for part of Warwickshire have been published, but this does not include any of southern Warwickshire. Both have excellent introductions dealing in detail with the scope and value of the Hearth Tax Returns.

The parishes selected here are close to the Oxfordshire border and Banbury itself. The number of hearths is only given when there are more than one.
